

GSSI COVID-19 Plan **UPDATE November 2020**

This chart is created as an “at-a-glance guide” for Girl Scouts of Southwest Indiana activities only and may be subject to change at any time based on government and GSUSA expectations.

IMPORTANT NOTE: Governor Holcomb’s recent announcement regarding large events does impact Girl Scout activities. Counties in orange will need to stay under 50 people and counties in red will need to stay under 25 people for all Girl Scout for activities. Please stay posted, GSSI will review changes to its [Back to Troop COVID Recommendations and Guidance](#) as needed. Below is an at-a-glance view of our current expectations, beginning November 16.

REMINDER: If participating in Girl Scout (in-person) activities, all individuals (members/non-members) **MUST** have a [COVID Waiver](#) completed and on file with troop leader.

| *Large Events (100+) | X | <i>Permitted with additional guidelines, contact GSSI</i> |
| *Money-Earning Activities | Permitted with participation restrictions, contact GSSI | <i>Permitted with additional guidelines, contact GSSI</i> |
| Resident Camp | X | TBD |
| *Day Camp (With Restrictions) | Permitted with participation restrictions, contact GSSI | <i>Permitted with additional guidelines, contact GSSI</i> |
| Volunteer Meetings/Trainings | Permitted (Outdoor spaces and small group interactions recommended) | <i>Permitted, small group interactions recommended</i> |
| Facial Coverings | Required if social distancing is difficult | <i>Recommended if social distancing is difficult</i> |
