New! Digital Cookie® Online Platform

Digital Cookie will replace ABC Smart Cookies as the online platform and app for girls to manage cookie orders. With Digital Cookies, girls can participate in online sales via their personalized link and e-cards sent to friends and family. Girls can also use Digital Cookie to accept credit card payments from customers and at cookie booths.

1. Register for Digital Cookie®

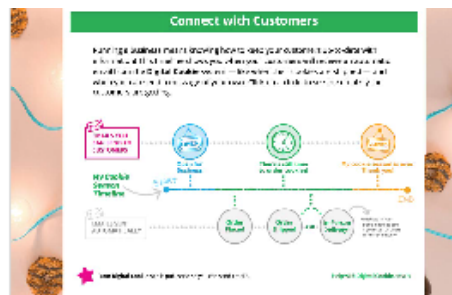

2. Set Up Your Site



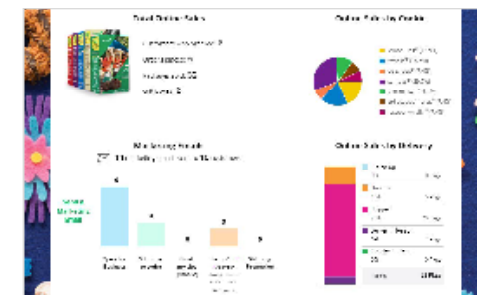
Take a few minutes to set your sales goal, share your cookie story, and upload a fun picture or video. Then publish and go!

3. Invite Customers



Use the emails in Digital Cookie to reach out to customers. Ask them to visit your site, purchase, and share your site. Also, post your site on social media.

4. Track Your Goal



Use your Digital Cookie platform to track sales and inventory and check progress towards your goal.

Important Information to Remember

- Adhere to all cookie program dates.
- Provide your troop cookie volunteer with all pre-orders by January 10, 2024, to ensure your Girl Scout receives her orders and early recognition items. **Don't forget to include girl delivery orders from Digital Cookie!**
- Parents/Guardians are financially responsible for all products and money received.
- When picking up cookies, you must count your inventory to confirm you received all cookies ordered.
- Be sure to get a receipt for any transactions between you and the troop, whether you're turning in money or picking up cookies.
- Remember that cookies cannot be returned to the troop or council once they're signed for.
- Checks should be made payable to Girl Scouts of Southwest Indiana (GSSI). Do not make checks out to the troop.
- Turn in cookie money to the troop when stated. Any girls with outstanding funds as of March 8, 2024, will be reported to the Product Sales department for collections. Girl recognitions and/or troop proceeds will be withheld until payment is received in full.
- Girls must have a Digital Cookie account to participate in the online portion of the Cookie Program.
- Posting on Facebook Marketplace, Craigslist, eBay, or any other website is strictly prohibited.
- **IMPORTANT:** Do not store cookies in a car, direct sunlight, a garage, on a cement floor, porch, patio, in any warm place, or any location where animals, bugs, water, etc. can damage them.
